COMMANDER'S CORNER



Hello Team March! It's great to be back in the 452d! I was assigned to the 730 AMTS (once a 452OG GSU) many years ago, and I'm looking forward to fully joining the team this time around. I'm happy to share my story and interested in hearing yours.

My story began in the service organizations of my childhood – most notably, Scouting. In the Scouts, we traditionally closed campfires with a song called the “Scout Vespers.” It is meant for individual reflection as it asks, “Have I done my daily task? Have I kept my honor bright? Can I guiltlessly sleep tonight?” What I failed to realize at the time was that those simple questions laid the foundation for a lifetime of service.

Today, if you ask any reservist why we serve you will get as many answers as people asked. 

SPOTLIGHT: MAINTENANCE GROUP



Welcome to the March UTA from the “Mighty M-X-G”! I want to discuss one of the big things going on in MXG that is transformative and innovative. This thing is called “ITP”. ITP stands for Integrated Technology Platform and is a Virtual Hangar that is supported by big Air Force. As of last summer, ITP had over 64 bases supported, over 300+ learning modules, and approximately 24,000 users supporting 23 AFSCs!

The program is fully funded by the Air Force for 5 years, and there are no licensing fees. We just need to procure the computer equipment to utilize the system. Currently, there are nearly 40 C-17 courses, 30+ KC-135 courses, and over 20 courses available for the KC-46 when it comes online here at March ARB.

Courses such as Hot Pit Refuel/Defuel, Engine Run, and Auxiliary Power Unit Operation are of particular interest because of the cost savings. Imagine getting reps on tasks that give you familiarization, count as a recent, or even potentially sign you off on a task as qualified! The savings in fuel costs alone will pay for the system in very short order.

I want to thank the Civil Engineering Squadron for renovating the area we plan to use for ITP. We have secured 4 computer stations from AMC and expect them to be delivered very soon. The 911th at Pittsburgh has been at the forefront of getting this technology into AFRC units, and the 434th at Grissom will come online shortly as well. Ultimately, we plan to have 10 stations for larger scenario training such as Aircraft Jacking Team and Aircraft Tow Team, which are two examples of larger team training scenarios.

I am very excited about getting our ITP Virtual Hangar off the ground and running. I cannot wait to show it off to my OG and MSG counterparts! I am also hopeful we will be able to share touch time on the system with them where it makes sense. For instance, there are Vehicle Maintenance training modules and Ops Aircraft Walk Around training modules available in the system already. There are more training modules being added to the system seemingly daily!

So why go virtual? Well, in this day and age this is how new Airmen prefer to learn and we need to modernize to these training methods. Several other reasons include: enhanced combat capability, increased readiness, and improved training while strengthening task understanding. Ultimately, it saves energy and decreases aircraft usage which are both finite resources.

This is just one of the very exciting things we have going on in the Mighty M-X-G. I want to thank you all for your service. We are an all-volunteer force, and we have all chosen to serve this great nation! Let's continue to meet the challenges in front of us by being "Ready Now!" Have a great UTA!

JAG: TAX SEASON TIPS

It's that time of year again; tax season is upon us! One of the most important tax considerations for servicemembers is determining their home of record. While you can be a resident of as many states as you would like, you can only have one domicile. Your domicile is your home of record. The state in which you are domiciled dictates where you owe state taxes. In many cases, servicemembers do not owe state taxes to the state they currently reside in because their home of record is a different state.

For instance, an active duty servicemember from Texas, who is stationed at March ARB, would not likely owe taxes to the state of California. The big question here is, "Where am I domiciled?" To be domiciled in a particular state, you have to have a legal connection to that state. In making a determination of which state you are domiciled in, you need to consider in which state you have a driver's license, in which state you vote, whether or not you have an address [that you can use] in that state, and whether or not you ever intend to return to that state.

Picking a favorable home of record could save you thousands of dollars in taxes. States like New Jersey, California, and New York have high-income taxes, whereas the states of Florida, Nevada, and Texas have absolutely no income tax. Other states, like Minnesota, Missouri, and New Mexico, either waive state income taxes for servicemembers or provide a discounted income tax percentage.

Your status as either an Air Reserve Technician (ART), Active Guard Reserve (AGR), Regular Air Force (RegAF), or a Traditional Reservist can have a huge impact on where your home of record (domicile) is.

Regarding taxes, ARTs are considered civilian positions. An ART would be required to have their home of record listed at or near the base in which they work. An ART who performs duties at March ARB would be subject to California state income tax.

Members of the AGR and RegAF are considered active duty. As active duty members, these individuals can maintain a home of record outside the state they are currently stationed. While these members can also have California as their home of record, if a legal connection exists to a different state, these members can rightfully claim a different state as their home of record.

Similar to AGR and RegAF members, Traditional Reservists (TR) serve under Title 10 of the United States Code. As such, a TR can have their home of record be in a state outside of California. However, if a TR is also an ART, the TR would be required to have California as their home of record.

HAZMAT SAFETY AWARENESS

A HAZMAT incident is not something the average servicemember considers in their day-to-day life on March Air Reserve Base. And yet, between August 11-13 in 2022 that very disaster occurred in the neighboring city of Perris when a railcar began to experience a styrene chemical leak less than a mile from the base perimeter. Highway 215 and other roadways were shut down or rerouted as HAZMAT response teams attempted to keep the scenario from getting out of control from 188,000 lbs. of a dangerous chemical building in pressure and heat, which ultimately could have resulted in an explosion that would have put the surrounding community in danger from toxic vapors. In the end, a solution was discovered that mitigated the threat of explosion, but it served as a reminder to the local communities of Southern California how serious a similar scenario could become.

To make matters worse, not six months after the Perris railcar incident, one of the worst HAZMAT events in modern U.S. history occurred in eastern Ohio. A HAZMAT cargo train derailed, catching fire and releasing hydrogen chloride and phosgene vapors to the surrounding area, as well as spilling multiple chemicals into local waterways and soil. The ongoing investigation, cleanup, and media fallout, combined with several subsequent train derailments in early 2023, highlighted yet again the importance of community awareness for HAZMAT incidents and the dangers that they pose.

The 452d Air Mobility Wing's Installation Office of Emergency Management (IOEM), through its installation EM program, seeks to ensure the continued safety of March ARB's personnel from a HAZMAT incident. Shelter-In-Place remains the best defense against a HAZMAT inhalation hazard, and every facility on the installation must have a compliant Shelter-In-Place program for

that reason. Facility Managers are provided detailed Shelter-in-place training with their Facility Manager immersion, and base personnel are briefed on shelter-in--Place procedures during the Base Emergency Preparedness Orientation with the Newcomer's Briefing. Servicemembers looking for additional information should direct their questions to their Facility Manager, Unit Emergency Preparedness Coordinator (UEPC), or the IOEM directly.




Figure 1: An image of a similar railcar to the one involved in the 2022 Perris HAZMAT incident.

DATA LOSS PREVENTION

1. Personnel assigned or attached to March ARB, including contractors fulfilling contractual duties, are responsible for sustaining the integrity, availability, and confidentiality of the information transported on 452d AMW's networks and information systems. The use of flash media on the Department of Defense (DoD) networks is prohibited per USCYBERCOM Communications Tasking Order (CTO) 10-084. A waiver process is available for squadrons/missions that would incur mission failure if the media is not available.
2. Universal Serial Bus (USB) storage devices are not authorized on unclassified information resources without previous written approval from the 452d Communications Focal Point and Wing Cybersecurity Office. Prohibited items include, but not limited to, USB storage devices containing flash media, cell phones, non-issued docking stations, and external hard drives.
3. Although most offenses are not malicious, it is critical for all to adhere to removable media standards. Do not under any circumstance plug a device into a DoD computer, even if only to charge your cell phone. Doing so constitutes a violation of the flash media ban.
4. Consequences for violating CTO10-084 by using unauthorized/prohibited devices are as follows:
 - a. User will immediately lose network privileges while an investigation of the violation is conducted. If the investigation concludes that no degradation was done to the network, the user will be permitted access back to network resources after the following is completed:
 - b. First offense: User must re-accomplish DoD Cyber Awareness Challenge and the user's Squadron Cybersecurity Liaisons (CL) will conduct remediation training with the user. A copy of the certificate of training, and an email from the user's CL stating "Remediation training has been conducted with the user." will be sent to the Wing Cyber Security Office before network privileges will be reinstated.
 - c. Second offense: In addition to what is outlined in the First offense, the user's Squadron Commander will digitally sign a letter of reinstatement for the user. Wet signatures, or electronically signed letters will not be accepted. A copy of the certificate of training, letter of reinstatement, and remediation training will be sent to the Wing Cyber Security Office before network privileges will be reinstated. Note: A letter of reinstatement from the individual's Squadron Commander is required before the user will regain access to the network.

d. Third offense and subsequent violations: the user will be suspended from network access for a period of not less than thirty calendar days. A letter of reinstatement from the Squadron's Group Commander is required before the user's network access will be reinstated. If access to the network is determined to be mission critical, the individual's Squadron Commander must contact the first O-6 in their chain of command to request network privileges be reinstated prior to the thirty-calendar day suspension.

e. While a user is under investigation, pending restoration of network access, or banned indefinitely from network access, no user will permit the violator to use his/her Common Access Card for computer access. If it is determined that a user permitted access for another user, then the consequence outlined in para 4 subpara. d will apply.

5. Investigations concluding with degradation or complete loss of network services from Data Loss Prevention violation, will be directly referred to the 452d Wing Commander or designate for adjudication.



CIVIL AIR PATROL CADETS RECEIVE INTENSIVE TRAINING FROM 452ND SECURITY FORCES SQUADRON




